TERMS AND CONDITIONS

ARTICLE 1 – ORGANIZATION OF THE CONTEST

Carenity France (hereinafter referred to as the "organizing company")

registered with the trade and companies register under the number:

whose registered office is located at 1 rue de Stockholm, 75008 Paris

Organizes from **24/06/2024** to **07/07/2024**, a free contest with no purchase necessary titled: "Win a pair of Viasox Non-Binding Diabetic Socks!" (hereinafter referred to as "the Contest"), according to the terms described in these rules.

ARTICLE 2 – CONDITIONS OF PARTICIPATION

This free contest is open to any individual aged over 18 years old, who has access to the internet and a valid email address and resides in the following countries: the United States of America, except for employees of the organizing company and their families, as well as anyone involved in the creation of the contest.

The contest is subject to the regulations of the US law applicable to games and contests.

The organizing company may ask any winner to prove their age before receiving their prize.

Participation in this contest implies full and unconditional acceptance of these rules.

ARTICLE 3 – PARTICIPATION DETAILS

The contest takes place on the Carenity platform on the dates mentioned in Article 1.

Participation in the contest is by commenting on the discussion "Win a pair of Viasox Non-Binding Diabetic Socks!"

Participants must choose a single unit pair of socks from Viasox's Non-Binding Diabetic Socks collection and mention their choice in their comment (no bundles allowed).

Participants can increase their chances of winning by making additional comments that will count as multiple entries; however, a single participant cannot win more than one prize.

ARTICLE 4 – SELECTION OF WINNERS

Five winners will be randomly selected within five days after the end of the contest.

The winners will be contacted within seven days following the draw, confirming the nature of the prize won and how to claim it. Any winner not responding within seven days of receiving notice of their win will be deemed to have forfeited the prize, and it will be awarded to a new winner.

The draw will determine five winners among the participants who commented on the discussion.

ARTICLE 5 – PRIZES

The contest features the following prize(s), awarded chronologically to the valid participants randomly drawn and declared winners. Each winner will receive one pair of Viasox's Non-Binding Diabetic Socks per winner.

The organizing company reserves the right to verify the age of any winner before awarding the prize. Prizes cannot in any case be exchanged for their cash value or any other prize. The organizing company shall not be held responsible for the use or non-use, or even the trading, of the prizes by the winners. In the event of force majeure, the organizing company reserves the right to replace the won prize with another of similar nature and equivalent value.

ARTICLE 6 – IDENTIFICATION OF WINNERS AND ELIMINATION OF PARTICIPATION

Participants authorize verification of their identity. Non-compliance with these rules as well as any fraud or attempt to cheat, in any form, will result in the immediate disqualification of the participant.

Participants in this contest accept the entirety of these rules. They can be obtained upon simple request at the address of the organizing company, specified in Article 1, for the duration of the contest.

8.1 Technical Issues:
